1 AN ACT concerning

2 **Maryland Employment Advancement Right Now (EARN) Program**

3 FOR the purpose of establishing the Maryland Employment Advancement Right Now
4 (EARN) Program (Maryland EARN Program) in the Department of Labor,
5 Licensing, and Regulation (Department); requiring the Department, in
6 consultation with the Department of Business and Economic Development and
7 the Governor's Workforce Investment Board, to establish and administer the
8 Program to provide certain grants on a competitive basis for certain purposes;
9 requiring applications for certain grants under the Program to include certain
10 information; authorizing certain grants to be awarded in a certain manner;
11 requiring the grant process to give priority to certain strategic industry
12 partnerships; authorizing the Department to adopt certain regulations;
13 requiring the Department to monitor certain grants; authorizing the
14 Department to impose certain requirements on certain recipients of certain
15 grants and to revoke certain grants under certain circumstances; providing that
16 certain intellectual property developed as a result of grants awarded under the
17 Program remain in the public domain under certain circumstances; requiring
18 the Department, in consultation with the Department of Budget and
19 Management to develop and implement a certain State employment
20 advancement strategy; requiring the Department, in consultation with the
21 Department of Business and Economic Development and the Department of

14 WHEREAS, Even in the most difficult economic times, Maryland has continued
15 to make significant investments in both the State’s K–12 and higher education
16 systems resulting in one of the most highly educated workforces in the country; and

17 WHEREAS, Despite these advances, many working families continue to face
18 significant challenges in obtaining skills and credentials necessary to secure stable
19 employment and to access opportunities for advancement in employment; and

20 WHEREAS, Maryland’s employers and economic growth industries continue to
21 lack skilled workers which inhibits the economic growth of the State; and

22 WHEREAS, Maryland’s workforce development system has many excellent and
23 highly ranked components that are often fragmented in a manner that inhibits the
24 potential for significant economic progress in the State; and

25 WHEREAS, Creating a coordinated system to advance the skills of the State’s
26 workforce through a collaboration of industry, State and local governments, and
27 nonprofits will grow Maryland’s economy; and

28 WHEREAS, Providing access to career ladders for employment advancement
29 and reducing barriers to employment can result in long–term improvements in the
30 economic well–being of working families and will assist in sustaining and growing
31 Maryland’s middle class; and

32 WHEREAS, Maryland’s ability to be competitive in the world economy will only
33 truly improve through working collaborations of public, private, and nonprofit
34 partners that make up the State’s workforce development system; and

35 WHEREAS, Providing skills training for the rapid employment advancement of
36 individuals while meeting the workforce needs of employers will promote both the
37 prosperity of working families and economic development in the State; now, therefore,

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

10 **(1) EDUCATIONAL DIPLOMA;**

11 **(2) CERTIFICATE OR DEGREE;**

12 **(3) OCCUPATIONAL LICENSE;**

13 **(4) APPRENTICESHIP CERTIFICATE;**

14 **(5) INDUSTRY RECOGNIZED CERTIFICATION; OR**

15 **(6) AWARD FOR SKILLS ATTAINMENT AND COMPLETION, ISSUED**
16 **BY AN APPROVED TRAINING PROVIDER IN THE STATE OR THIRD-PARTY**
17 **CREDENTIAL PROVIDER.**

18 **(C) “HIGH-DEMAND OCCUPATION” MEANS AN OCCUPATION THAT:**

19 **(1) HAS A SIGNIFICANT PRESENCE WITHIN TARGET INDUSTRIES;**

20 **(2) IS IN DEMAND BY EMPLOYERS; AND**

21 **(3) PAYS OR LEADS TO PAYMENT OF A FAMILY SUSTAINING WAGE.**

22 **(D) “IDENTIFIABLE SKILL” MEANS THE ATTAINMENT OF PROFICIENCY**
23 **IN A SPECIFIC WORK-RELATED SKILL THAT IS LIKELY TO LEAD TO FUTURE JOB**
24 **ADVANCEMENT AND IMPROVEMENT IN AN INDIVIDUAL’S EARNING POTENTIAL.**

25 **(E) (1) “JOB READINESS TRAINING” MEANS TRAINING FOR THE**
26 **PURPOSE OF ASSISTING AND SUPPORTING JOBSEEKERS IN OVERCOMING**
27 **INDIVIDUAL BARRIERS TO EMPLOYMENT AND DEVELOPING THE SKILLS**

1 NECESSARY TO MAINTAIN EMPLOYMENT AND TO QUALIFY FOR SKILLS TRAINING
2 OPPORTUNITIES.

3 (2) "JOB READINESS TRAINING" INCLUDES:

4 (I) OCCUPATIONAL SKILLS DEVELOPMENT;

5 (II) GED PREPARATION;

6 (III) LITERACY ADVANCEMENT;

7 (IV) FINANCIAL STABILITY SERVICES, INCLUDING
8 FINANCIAL COACHING;

15 (G) "MARYLAND EARN PROGRAM" MEANS THE MARYLAND
16 EMPLOYMENT ADVANCEMENT RIGHT NOW PROGRAM CREATED UNDER THIS
17 SUBTITLE.

18 (H) "STRATEGIC INDUSTRY PARTNERSHIP" MEANS A COLLABORATION
19 THAT BRINGS TOGETHER A REGIONAL GROUP THAT MAY INCLUDE EMPLOYERS,
20 NONPROFITS, INSTITUTIONS OF HIGHER EDUCATION, COMMUNITY COLLEGES,
21 LOCAL BOARDS, LOCAL GOVERNMENTS, OR OTHER RELEVANT PARTNERS TO:

22 (1) IDENTIFY COMMON WORKFORCE NEEDS FOR HIGH-DEMAND
23 OCCUPATIONS WITHIN A TARGET INDUSTRY; AND

24 (2) DEVELOP AND IMPLEMENT INDUSTRY STRATEGIES TO MEET
25 THE COMMON WORKFORCE NEEDS AND SHORTAGES BASED ON REGIONAL
26 NEEDS.

27 (I) "TARGET INDUSTRY" MEANS A GROUP OF EMPLOYERS CLOSELY
28 LINKED BY A COMMON PRODUCT OR SERVICE, WORKFORCE SKILLS, SIMILAR
29 TECHNOLOGIES, SUPPLY CHAINS, OR OTHER ECONOMIC TIES.

29 **OCCUPATIONS OR SETS OF OCCUPATIONS WITHIN THE TARGET INDUSTRY; AND**

30 (III) **THE SPECIFICS OF TRAINING PROGRAMS THAT WOULD**
31 **RESULT IN INDIVIDUALS OBTAINING CREDENTIALS OR IDENTIFIABLE SKILLS TO**

1 FACILITATE THEIR EMPLOYMENT OR ADVANCEMENT IN THE TARGETED
2 INDUSTRY; AND

3 (2) IDENTIFY MEMBERS PARTICIPATING IN THE STRATEGIC
4 INDUSTRY PARTNERSHIP AND INCLUDE IDENTIFICATION OF THE TARGET

9 (1) INDUSTRIES WITH IDENTIFIED POSITIONS AND A
10 DEMONSTRATED NEED FOR INCUMBENT WORKER TRAINING THAT CAN BE
11 ACCESSED BY EMPLOYEES AT THEIR PLACE OF EMPLOYMENT OR OTHER
12 LOCATION;

13 (2) INDUSTRIES WITH AN IDENTIFIED WORKFORCE SHORTAGE
14 THAT WILL BE SEEKING TO HIRE INDIVIDUALS TO TRAIN TO MEET A SPECIFIC
15 SKILL NEED;

16 (3) A MEMBER OF A STRATEGIC INDUSTRY PARTNERSHIP THAT
17 CAN PROVIDE JOB READINESS TRAINING TO QUALIFIED INDIVIDUALS DIRECTLY
18 OR THROUGH ACCOUNTS HELD AT LOCAL BOARDS ON BEHALF OF THE
