Table C is in effect for 2022 and includes rates from 1.0% to 10.50%. An employer's benefit ratio and tax rate are listed on the employer's Experience Rate Notice, sent to employers in January and also available in <u>BEACON 2.0</u>. To view in BEACON, select "Tax Rate Functions" from the left menu, and then select "Rate Notice."
