SUBJECT: Local WIA Allocations for PY 2013 and FY 2014

REFERENCES: Training and Employment Letter Guidance Letter No. 25-12 Workforce Investment Act of 1998, (29 U.S. Code 2801 etseq,) Public Law 105-220, as amended WIA Final Rule, 20 CFR 660-671 Planning Guidance for the Strategic State Plan for Title I of the Workforce Investment Act of 1998 and the Wagner-Peyser Act (OMB No. 1205-0398)

BACKGROUND

INFORMATION: TEGL 25-12 announced the PY 2013 and FY 2014 State allotments for WIA Adult, Youth and Dislocated Workers. Sequestration reductions are fully applied to the PY 2013 funding. The PY 2013 and FY 2014 Local WIA allocations are attached. Up to 10% of the allocation can be used for administrative expenditures. PY 2013 Youth funding is available effective April 1, 2013. To receive Youth funding effective April 1, 2013, the LWIB must submit Youth original signature sheets and narrative upon receipt of this WIFI. The PY and FY funding is awarded as separate grants, and must be recorded and reported as separate grants.
