 - Staff and Business Engagement: examples of speakers could include different levels of staff, a member of the Governor's Workforce Development Board, business services staff, and an industry association.

- Participant Engagement and Outreach: examples of speakers could include the Chair of the Communications Committee, Community Action Agencies, a training provider, and a vendor for DHS.
- o **Performance**: examples of speakers could include Doug Weimer, Lynda Weber, and local performance staff.
