#### **MINUTES - WEDNESDAY, DECEMBER 20, 2017**

On Wednesday, December 20, 2017, the Maryland State Athletic Commission meeting was called to order by Chairman Arnold "Arnie" Dansicker at 2:07 p.m.. Present were the following: Chairman Dansicker; Commissioner Lenny Moore; Commissioner David Norman; Commissioner David Shull; Dr. John W. Stiller, M.D., Commission Chief Physician; Patrick Pannella, Executive Director; Eric London, Assistant Attorney General and Counsel; and Dreama Anderson, Administrative Specialist.

## MOMENT OF SILENCE PASSING OF DAVID "DAVE" ARBOGAST

The Commission held a moment of silence in honor of Dave Arbogast, who served as the Chief Inspector of the Maryland State Athletic Commission and who passed away on November 21, 2017 at the age of 53.

Chairman Dansicker stated that, in addition to his employment with the Commission during the past four years, Mr. Arbogast "gave back to his community" and maintained an extensive record of service as a volunteer firefighter.

Executive Director Pannella stated that Mr. Arbogast was a familiar face to Commission licensees at combative sports weigh-ins and events and at wrestling events, adding that Mr. Arbogast was well-known and well-respected for his calm demeanor and straightforward personality.

Administrative Specialist Anderson stated that Mr. Arbogast thoroughly enjoyed his inspector duties with the Commission at various boxing, MMA and wrestling events sanctioned and regulated by the Commission, adding that he "had his work down to a science".

The Commission expressed its deepest condolences to the family of Mr. Arbogast.

## MOMENT OF SILENCE PASSING OF PATRICIA HAZZARD

The Commission held a moment of silence in honor of Patricia Hazzard, who was the wife of Commissioner Larry Hazzard of the New Jersey Athletic Control Board.

Executive Director Pannella stated that Commissioner Hazzard and his wife were married for over 53 years, noting also how Mr. Hazzard maintains close and valuable ties to the Commission in fostering boxer safety.

The Commission expressed its deepest condolences to Mr. Hazzard and the entire family of Mrs. Hazzard.

#### **CHAIRMAN'S REPORT**

Chairman Dansicker provided the Commission with the following report as a review of Commission activity for the year 2017.

The Commission welcomed a new Commission member in David Shull and lamented the passing of Commissioner Ben Alperstein.

The Commission saw wrestling and MMA "flourish" in the past year, while it gained national interest and attention by effectively regulating several major televised boxing events at MGM National Harbor in Oxon Hill, Maryland.

Commission members maintained consistent communication with Executive Director Pannella and Assistant Attorney General London, frequently reviewing

and discussing various matters in an effort to maintain high regulatory standards in overseeing the sports for which it is responsible.

Most of all, the Commission never steered away from its strong obligation to protecting combatants – from not approving the mismatching of opponents to taking regulatory action to ensure that a contestant is paid for having competed in a contest.

#### **COUNSEL'S REPORT**

Counsel London reported that all four current Commission members made their obligation to attend two-thirds of Commission meetings held during the previous year.

Counsel London recognized Commissioner Norman for his noteworthy assistance with the Commission's legal analysis in the formal protest of professional boxer Jose Uzcategui.

# REMARKS BY CHIEF COMMISSION PHYSICIAN DR. JOHN W. STILLER, M.D.

Chief Commission Physician and Neurologist Dr. John W. Stiller, M.D. provided the Commission with the following report as a review of Commission activity for the year 2017.

The Commission continued to build upon its national reputation for being "strict" by "putting safety and health first" with regard to its regulatory treatment of contestants.

Commission staff made significant contributions toward supporting fighter safety. This was reflected by the strong communication which existed between the Commission's referees and ringside physicians during contests. Other examples include the Commission physician who was extremely knowledgeable about the boxing history of amateur boxers and who provided such information to the Commission when the Commission considered approving a contest involving a pro debut contestant, and the timekeeper who consistently documented the length of

time a contestant was unconscious after being knocked out so that the Commission physician could utilize such information to medically evaluate the injured contestant.

Researching a contestant's fight history and taking significant measures to obtain credible information in order to make informed regulatory decisions remained a very high priority for the Commission.

# REVIEW OF OCTOBER 7, 2017 "SHOGUN FIGHTS 17" MMA EVENT

Commissioner Shull and Executive Director Pannella led a Commission review of the professional MMA event which was promoted by John J. Rallo, III, advertising as "Shogun Fights 17", and held on October 7, 2017 at The Royal Farms Arena in Baltimore, Maryland. The professional MMA event included ten professional MMA contests and 30 scheduled rounds of professional MMA competition.

Commissioner Shull applauded Commission staff members for the highly professional manner in which they handled both the medical evaluation and medical evacuation of an injured contestant who required hospital transport.

Executive Director opined that this was another quality MMA event in the ongoing "Shogun Fights" series.

# REVIEW OF NOVEMBER 2, 2017 "AN EVENING TO BENEFIT THE JONATHAN OGDEN FOUNDATION" CHARITY MMA EVENT

Commissioner Moore and Executive Director Pannella led a Commission review of the professional MMA event which was promoted by John J. Rallo, III, advertising as "An Evening To Benefit The Jonathan Ogden Foundation", and held on November 2, 2017 at Martin's Valley Mansion in Hunt Valley, Maryland. The professional MMA event included five professional MMA contests and 15 scheduled rounds of professional MMA competition.

Executive Director opined that several of the MMA contests featured were very

competitive.

## REVIEW OF NOVEMBER 30, 2017 PROFESSIONAL BOXING EVENT

Commissioner Norman and Commissioner Shull led a Commission review of the professional boxing event which was promoted by Golden Boy Promotions, LLC, televised on the ESPN network, and held on November 30, 2017 at MGM National Harbor in Oxon Hill, Maryland. The professional boxing event included six professional boxing contests and 40 scheduled rounds of professional boxing competition.

Commissioner Norman, Commissioner Shull and Chief Commission Physician Dr. John W. Stiller, M.D. all commented as to how highly competitive virtually all of the boxing contests were.

Dr. Stiller noted, further, that the Commission worked diligently behind-the scenes to support the efforts of the promoter in staging such a successful boxing event.
